## Eligibility Criteria

As per the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of officer, resignation and removal of the Presidents and members of the State Commission and District Commission) Rules, 2020, the qualification prescribed for appointment of members in the Consumer Commission are as under:

Consumer Commission	Eligibility	
State Commission	Prescribed under sub rule 2 of rule 3	A person shall not be qualified for appointment as a member unless he is of not less than forty years of age and possesses— (a) an experience of at least ten years as presiding officer of a district court or of any tribunal at equivalent level or combined service as such in the district court and tribunal: Provided that not more than fifty percent of such members shall be appointed; or (b) a bachelor's degree from a recognised university and is a person of ability, integrity and standing, and has special knowledge and professional experience of not less than twenty years in consumer affairs, law, public affairs, administration, economics, commerce, industry, finance, management, engineering, technology, public health or medicine
District Commission	Prescribed under sub rule 2 of rule 4	A person shall not be qualified for appointment as member unless he- (a) is of not less than thirty-five years of age; (b) possesses a bachelor's degree from a recognised University; and (c) is a person of ability, integrity and standing, and having special knowledge and professional experience of not less than fifteen years in consumer affairs, law, public affairs, administration, economics, commerce, industry, finance, management, engineering, technology, public health or medicine

Tenure: The appointment shall be on part-time basis for a period of four years or up to the age of 65 years, whichever is earlier.

Selection Procedure: Selection of the Members of the Consumer Commission shall be made by the Selection Committee constituted vide Sikkim Government Extraordinary Gazette Notification No. 164 dated 22<sup>nd</sup> July 2021 as mandated under Rule 6 of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of officer, resignation and removal of the Presidents and members of the State Commission and District Commission) Rules, 2020.
